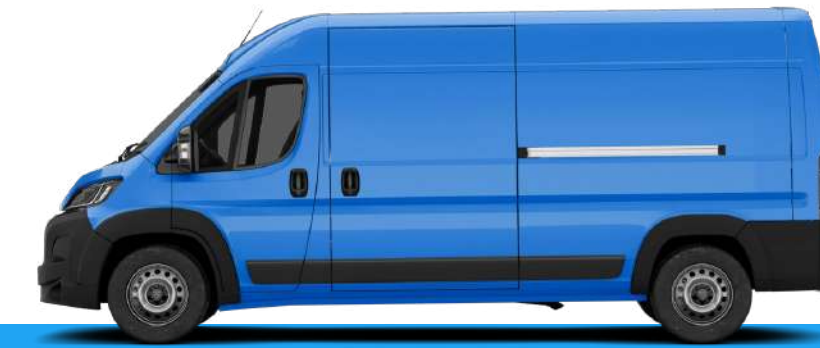

It's a win-win for both employees and employers. Employees save on Tax and National Insurance Contributions (NIC), and employers also enjoy NIC savings.

Employees do pay Benefit in Kind tax (BiK) because they're receiving a non-cash benefit from their employer. The great news is that rates are exceptionally low for Electric Vehicles (EVs) at just 2% of the P11D value of the car until 2025.
