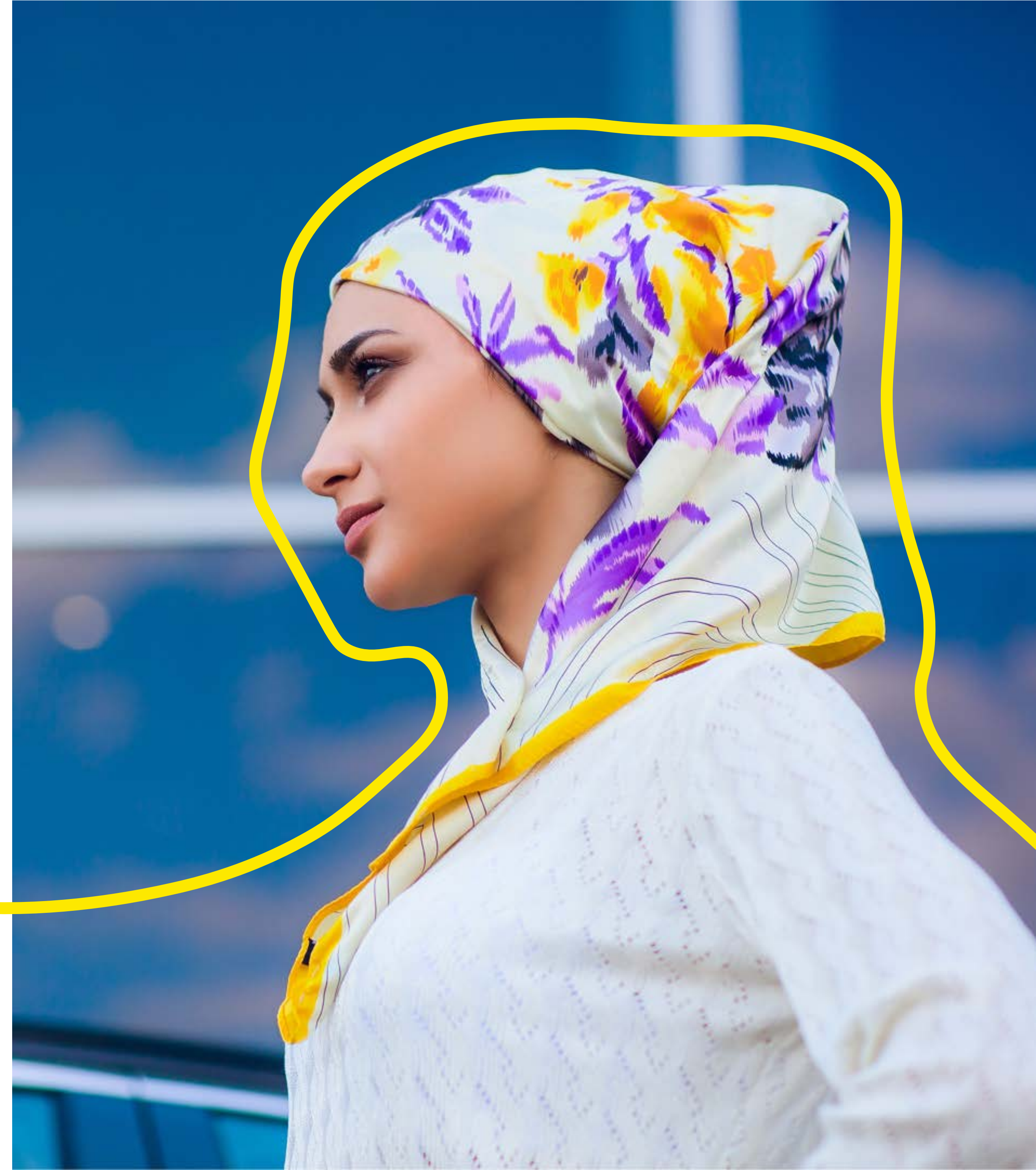

Transparency matters

Personal Contract Hire offers numerous benefits, but there are some key points to keep in mind.

When leasing a vehicle, you must arrange fully comprehensive insurance. It's also important to set a realistic mileage allowance, as exceeding it will result in excess mileage charges outlined in your lease agreement.¹

To avoid additional costs, the car must be kept in good condition and serviced regularly, following the manufacturer's guidelines. At the end of your lease, the vehicle will be inspected under BVRLA² Fair Wear and Tear standards.

If you need to end your lease early, an early termination fee will apply, with costs depending on your agreement, the car's value, and the remaining contract length.

Frequently Asked Questions

What is Personal Contract Hire?

The vehicle must be returned in good condition, in line with BVRLA Fair Wear & Tear guidelines. Any excessive damage or missing parts will result in additional charges.

Do I need to pay tax on my cash allowance?

Yes, a cash allowance is considered part of your salary and is subject to income tax and National Insurance. However, by choosing a fuel-efficient vehicle with lower running costs, you can make the most of your allowance.

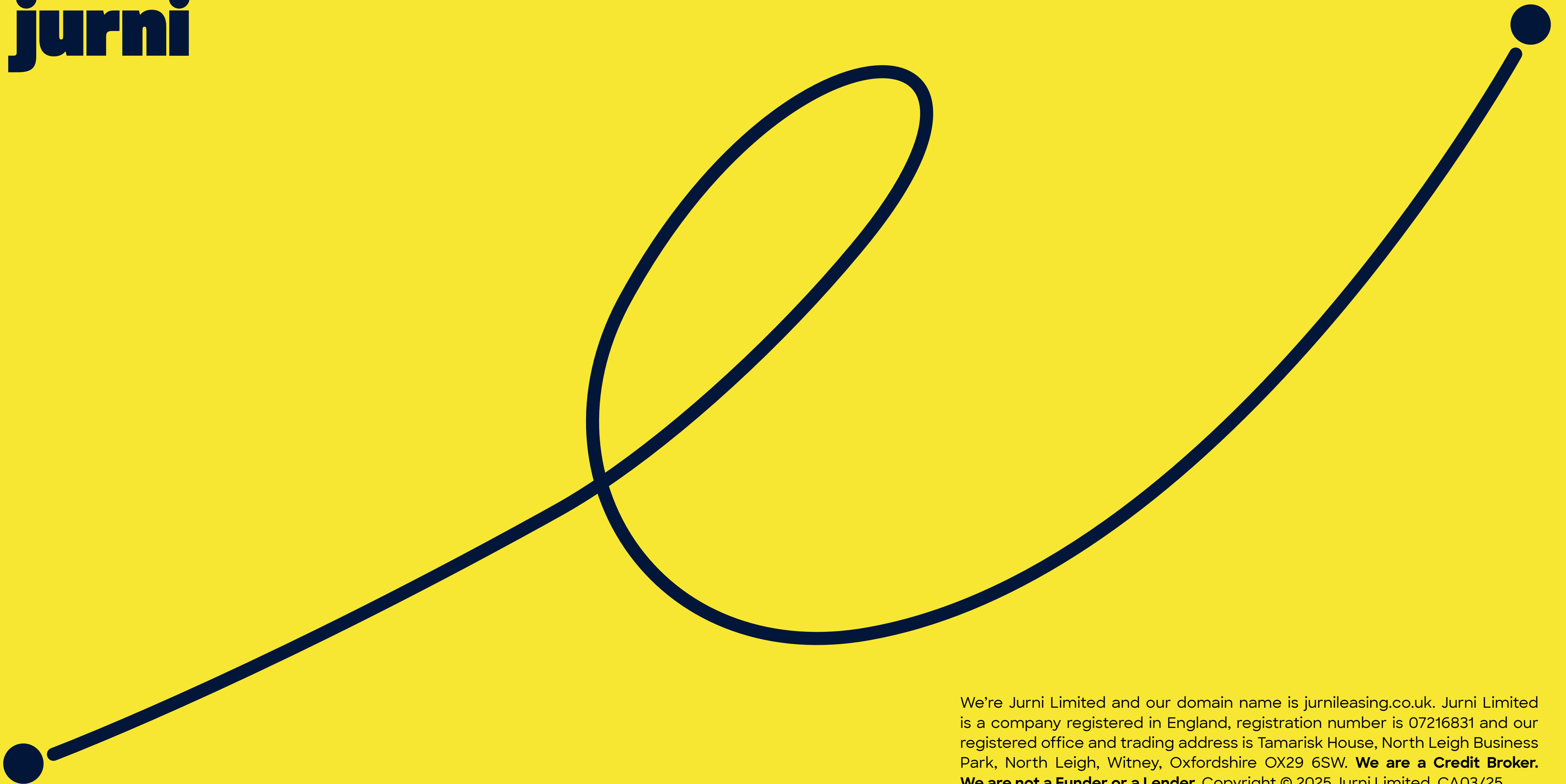
